\*Note: A 50% matching grant in the amount of \$2025 was made by the Virginia Commission for the Arts for concerts presented in retirement communities beginning on July 1, 2007. The grant provides 50% of cash expenses totaling no more than \$4050. \$4206 was actually spent to provide five concerts, one in the prior year and four in FY 2008, fully utilizing the available grant funds. The cash expenditures for the concert in the prior year were \$1050, and \$525 was therefore claimed as revenue for the FY 2007 fiscal year. The remaining \$1500 in available grant income is claimed as revenue for the FY 2008 fiscal year. This grant is listed separately because of its exceptional nature.

Note: Above figures for FY 2008 include \$4050 program for performances in retirement communities, funded at 50% by a \$2025 grant from the Virginia Commission for the Arts. A portion of the program was begun in FY2007, and a remainder of \$3000 (\$1500 in VCA grant money) was expended in FY2008. This is considered an extraordinary item, which is not included in the budget for FY 2009.

\*Per direction from the membership at the Annual Meeting held in November 2005, surplus revenues are sought and will be used to build a fund of cash reserves equal to one year of budgeted expenditures. FY2008 was the first year a surplus was available (prior years showed small losses), and this directive will be included as a budget item for this and future years.
